







#### **ENTITY**

SPMS is a public enterprise created in 2010, functioning under the quardianship of the Ministries of Health and Finance. Its mission is to provide shared services in the areas of purchasing and logistics, financial services, human resources and information systems &technologies to organisations operating specifically in the area of health, in order to "centralise, optimise and rationalise" the procurement of goods and services within the NHS.

Striving for transparency and efficiency in performing procedures, SPMS subscribed to the innovative process of VORTAL electronic auctions.

#### **PREPARATION**

In the 1st auction held by SPMS E.P.E - Shared Services Ministry of Health, through centralized purchasing in which 42 of 52 health institutions participated, there was an overall concern with participating suppliers in the auction (29) both on the side of VORTAL and Board of Directors of SPMS.

These suppliers were invited for a training session in the SPMS installations, where they could clarify all their doubts and simulate the real auction in a test area.

## **AUCTION**

In the day of 13.11.2014, SPMS E.P.E - Shared Services Ministry of Health, in representation of 42 institutions the National Health System, held a composed auction of 31 Lots for acquisition of drugs for oncological or respiratory diseases.

The use of this tool offered total transparency in the procedure since all participating suppliers had access to best prices, enabling each supplier to know their ranking automatically and in real time. Therefore it was possible improve their positioning in different lots of the procedure.

With the completion of the electronic auction, SPMS E.P.E managed to achieve savings of € 358.291,86.
