Procurement Contract Manager

A single central repository with all proposals and related contracts and a complete view of existing commitments. Overall visibility on contracts, and tasks.

Association between different contacts

Link different contracts to ensure traceability. If one is changed, the system alerts if there are impacts to be monitored and corrected in the related contracts.

Contract Documents

Define if the contract predicts authorization codes for invoice registration, to control the invoices emission.

Advanced Payments

Buyers can set up advanced payments defining the amortization plan for each future invoice.

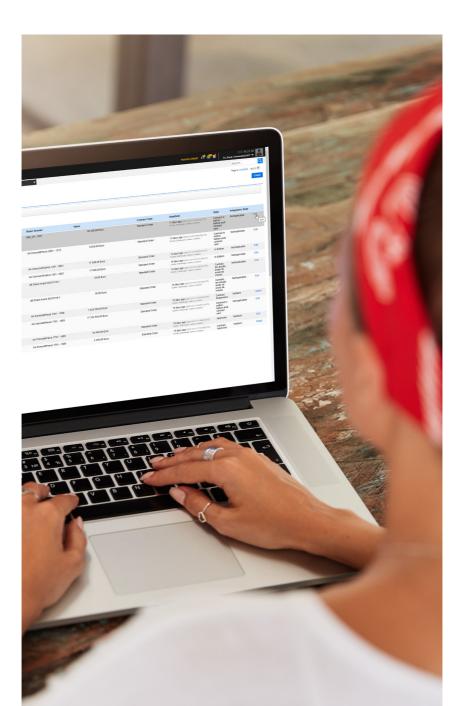
